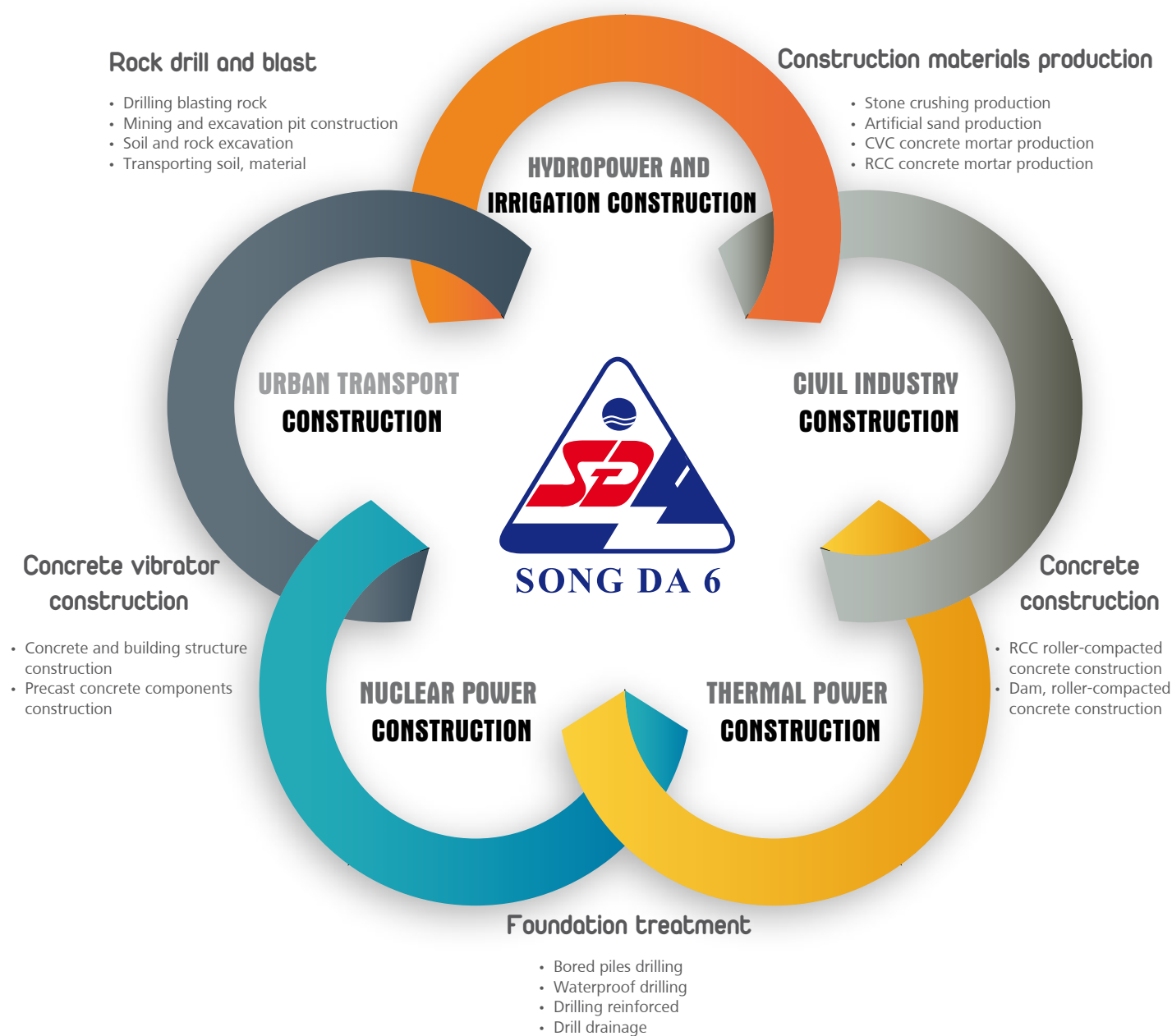

- Dated **December 9th 2005**, Song Da 6 Company converted to active in the form of Joint stock company

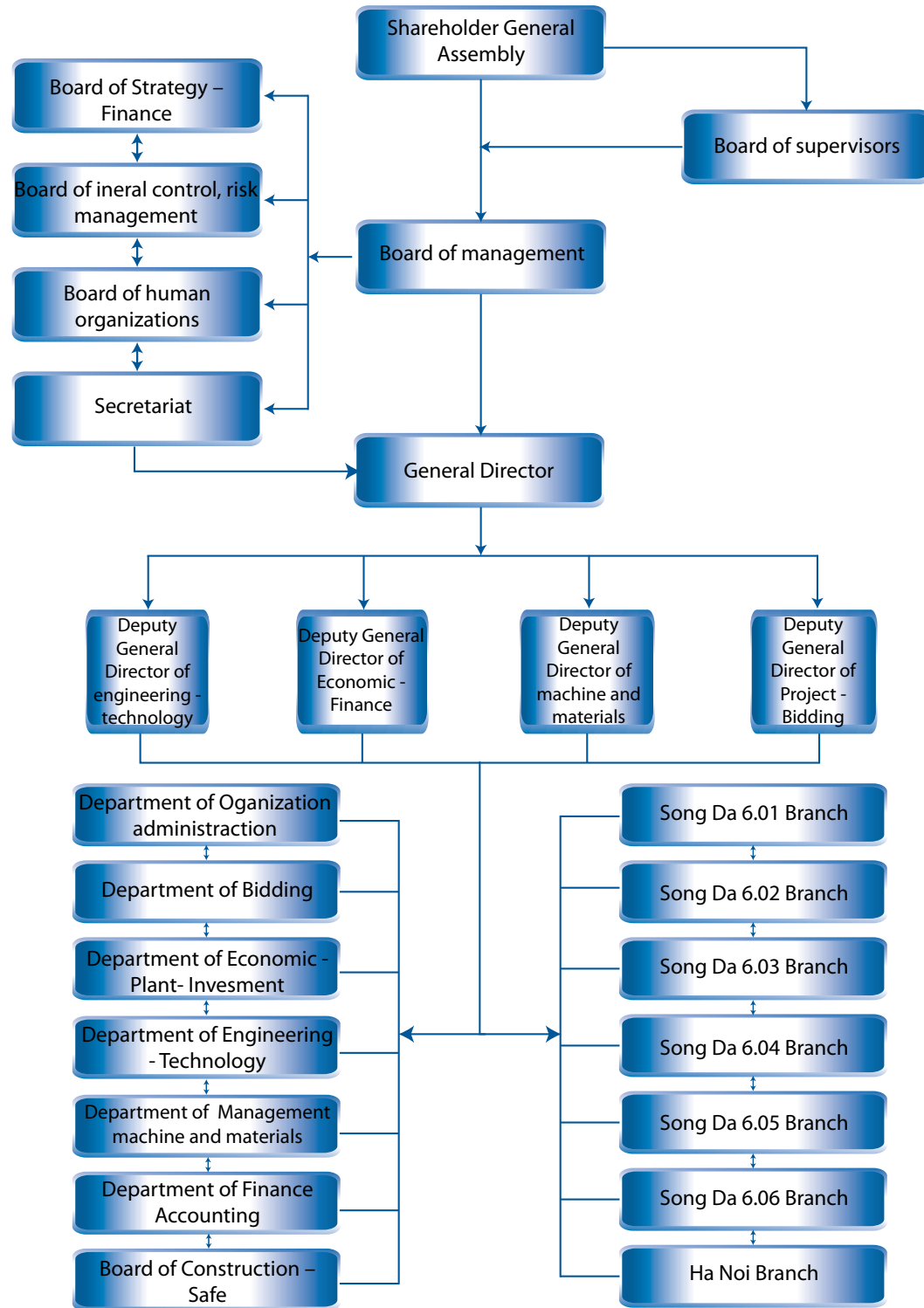

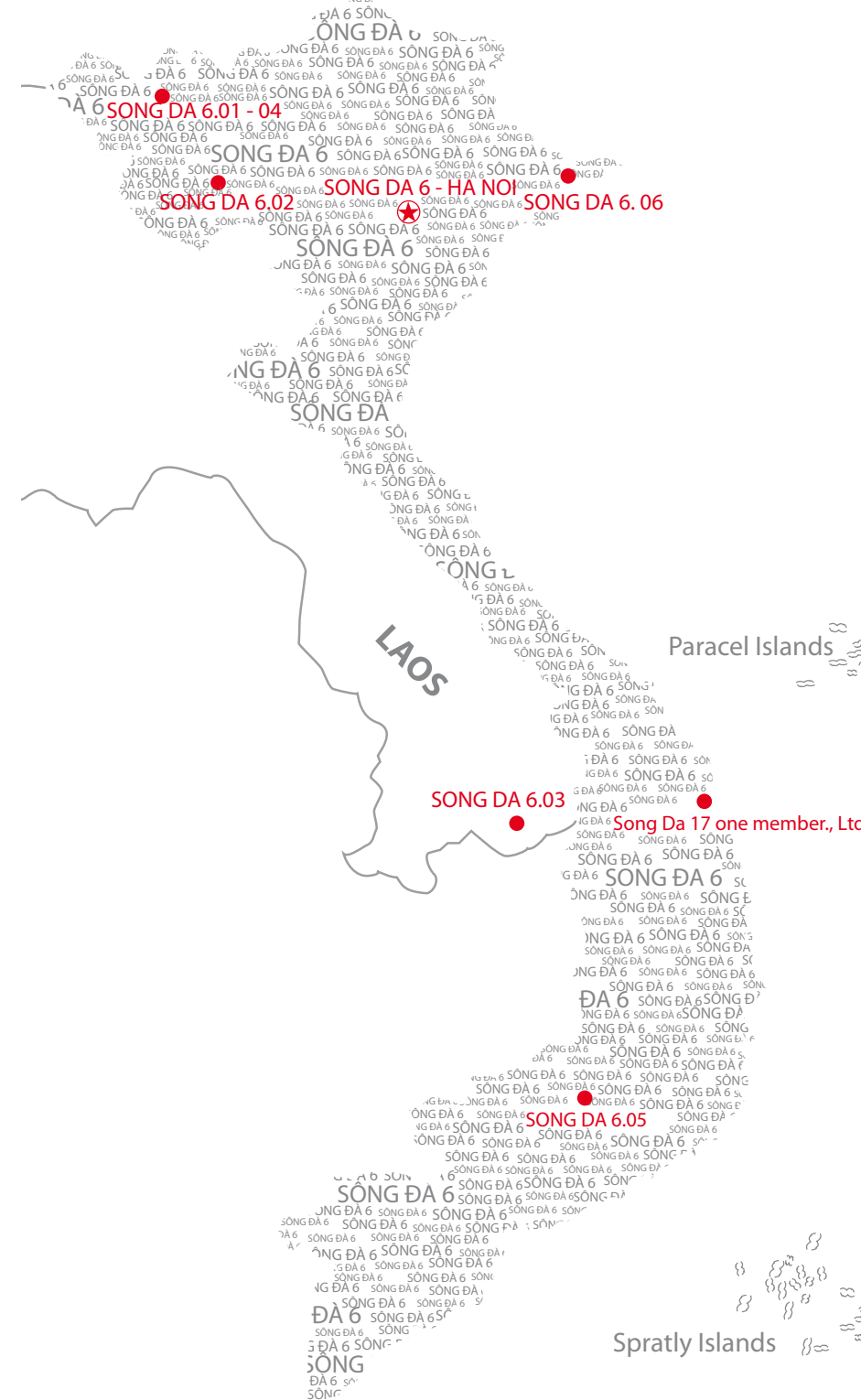

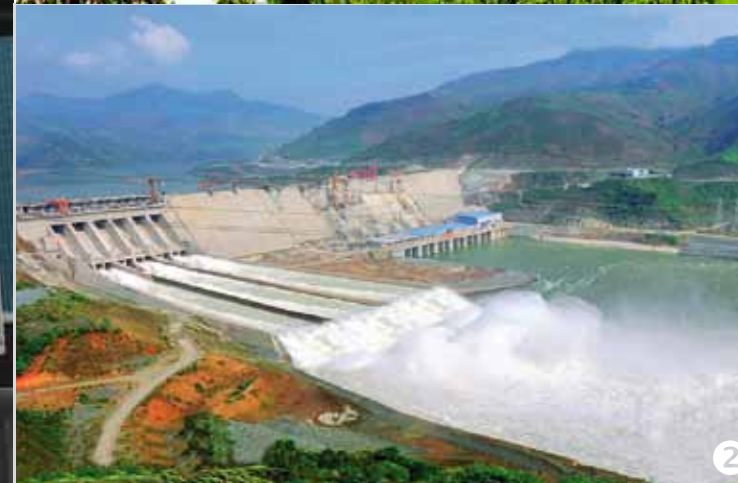

Scope of Hydropower construction

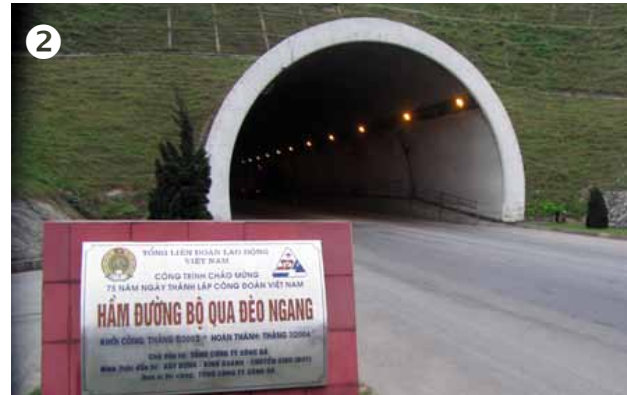
